Terms and Privacy Policy

Privacy Policy:

At TerraSync Private Limited, we take plant/ Industries privacy seriously. The said information collected from the plant/ Industries could be categorized as "Sensitive Information", "Banking Information" and "Associated Information".

OCEMS is an application platform to display various sensors data and we collect following personal credentials/data for below mentioned use:

1. Admins:

Admin is the head of Plant. We collect name, plant name, mobile number, address, plant capacity, plant email for his/her better convenience and team management. It helps the admin to monitor and manage plant data in a user friendly manner.

2. Officer:

Officers are users working in a plant, holding designation of a particular department, assigned by admin to assist monitoring the plant data and take actions if required. We collect officer's names, contact number, job post for admin's convenience to monitor data.

3. Team member:

Team members are users working in a plant, holding designation of a particular department, assigned by an Officer to assist monitoring the plant data and take actions if required. We collect Team member's names, contact number, job post for admin's convenience to monitor data.

4. Industries:

Industries will have their separate login credentials to monitor and manage their personalized data only and make the payment of bills.

Data Storage:

We store plant/ Industries data on a third party reputed company's server to keep it safe and secure. This data may be used by third party companies to assist us with better understanding of Plant Working which we can further use for optimization purposes.

We do not store collected information on our servers. These contents are stored on google platforms like firebase realtime database and firestore.

Data Security:

We implement appropriate security measures to protect plant/ Industries personal information against unauthorized access, alteration, disclosure, or destruction.

We shall try to take all precautions to protect the personal information both online and offline. We will try to protect your information using technical and administrative security measures to reduce the risks of loss, misuse, unauthorized access, disclosure and alteration. We use google services to create secure connections. Some of the safeguards we use are firewalls and data encryption, physical access controls to our data centres and information access authorization controls. If you believe your account
